This has been another busy year for the Frank H. Kenan Chapel in Landfall. Two projects for 2017 were designed to update our communications and outreach to

Landfall residents and the larger community.

For the first time, the Board of Directors created and adopted a mission statement for the Chapel: To provide a tranquil, serene setting for spiritual, ceremonial and cultural events for residents of Landfall and of the larger community.

The tranquil and serene setting is certainly evident in the beautiful interior of the Chapel with the many tasteful antiques, such as the chandeliers, baptismal font, English hall chairs, and 1st Empire French chest. Park benches are located throughout the Memorial Gardens, offering restful locations for peaceful contemplation amongst beautiful mature trees and circular walkways.

Spiritual and ceremonial events that can be performed in the Chapel include the complete life cycle of baptisms, weddings, and memorial services as well as individual meditation and prayer. The Chapel also provides a venue for renewal of marriage vows.

The fabulous acoustics provide a perfect venue for the free Sunday evening concerts. The 2016-2017 season saw a diverse cultural program of entertainment (more of this in the Music Committee article). In a sense, the Chapel belongs to all of Landfall, but it is also open to the public. For a modest fee, it may be rented for special events such as weddings, recitals, baptisms, and memorial services.

Our hosting of the annual Landfall Fall Festival has become a legendary entertainment and recreational experience. This year Co-Chairs Steve Burdt and Mike Kane certainly out-did themselves in expanding the Halloween theme for this fundraising event, which saw a record crowd enjoying the festivities.

The second broad step taken this year was by Jessica Spencer and her team who have expanded the Chapel's social media outreach (more about this later in the newsletter).

Overarching our mission statement is the need the Chapel meets for many Landfall residents in providing a final resting place for their cremains. The Memorial Gardens have been blessed and sanctified by all the major faiths. We offer several options, all designed to meet individuals' specific wishes and requirements. I want to express a special thanks to the Chapel Board of Directors for their sage guidance in managing Chapel matters and providing me with sound advice. Without them, we would not function. Sue Patterson, as Communications chair, has kept the community informed of the Chapel's activities. # FROM THE MUSIC COMMITTEE

The Kenan Chapel Music Committee, chaired by Reuben Allen, is dedicated to presenting young, talented, emerging musicians in free concerts to the community. Our concerts perform to full houses with standing ovations at the conclusion of the programs. Most of the concerts are followed by receptions at the Country Club of Landfall, attended by the musicians as well as audience members.

Our 2017 concert series began with a program featuring Nancy King and her opera students from the University of North Carolina Wilmington. In February, we hosted the Wilmington Symphony Concerto winners. North Carolina School of the Arts in Winston-Salem presented our concerts in March and April. The first was a UNCSA Chamber Group, and the second was a collaborative piano concert. The Tallis Chamber Orchestra returned for our annual Mothers' Day Concert in May. And in June, for the ninth year, the Port City Music Festival opened its concert series at the Chapel.

Stephanie Nakasian and Friends opened our fall concerts with a jazz program in September. The Coastal Strings presented a warmly received chamber music concert in October. The Kenan Music Scholars brought eleven of their students from University of North Carolina Chapel Hill for their recital in November. On Dec. 17, we will welcome community residents to our third annual Christmas caroling at the Chapel.

Our 2017 series presented a a wonderful variety of concerts at the Chapel. We plan to continue that tradition in 2018. The schedule for next year is being finalized now. The Tallis Chamber Orchestra will be back as well as the Port City Music Festival.

Concerts tickets will be available, as in previous years, at the Reference Desk, of the Northeast Library, beginning the Monday before Sunday concerts or, in the event of a Monday holiday, on Tuesday. We welcome suggestions regarding the programs.

Performing as a trio, they have extended their group to other small ensembles such as Tallis Chamber Orchestra, enriching this very special Cape Fear arts community. They enjoy performing in our Kenan Chapel and are very appreciative of the support from us.

## **COMMUNICATIONS COMMITTEE**

The Communications Committee of the Kenan Chapel set new objectives this year to continue work to achieve the long-range communications goals developed last year.

Early in the year, the Committee led the Board of Directors through a process to develop a mission statement for the Chapel. The mission statement, approved by the Board, reads: To provide a tranquil, serene setting for spiritual, ceremonial and cultural events for residents of Landfall and of the larger community.

In his letter in this issue, President Leon Socha discusses how the Chapel fulfills this mission through its events and programs.

Throughout the year, Committee members Jessica Spencer and Sue Patterson worked with Arrangements Committee Chair Trish Boyd to develop a marketing plan designed to increase wedding bookings at the Chapel. They researched national trends and changes in preferences for wedding venues, looked at local competition and preferences, and

evaluated the Chapel as a venue in light of the new information.

In her report for the Arrangements Committee, Trish Boyd outlines new marketing steps taken as the result of the marketing plan.

The Committee continued its efforts to strengthen the Chapel's social media position through Facebook, Instagram, WeddingWire, and the Chapel's website. Publicity for the Fall Festival and for the Sunday concerts was expanded from print media to extensive use of these outlets. Jessica Spencer continued to lead this effort.

Jim Martz, who handles publicity for the concerts, has obtained excellent coverage in both Landfall publications and others distributed in the area. Sue Patterson created the publicity for the Fall Festival. Taylor Johnson and Jim Martz generously donated their time and photography talents to enhance both print and social media communication. Avery Wilmeth continued to provide technical assistance, both for the web site and creation of this annual newsletter.
